Thank you for your courage and curiosity in considering the information contained in this book. Your willingness to open yourself to this information is a gift to your family. I have a core belief that everyone does the best they can with what they know. The challenge of life is that we are often required to make decisions without adequate information.

You might ask what my intention is in writing this book. The answer is - I want you to be as informed as possible about the medical practice of vaccination. I also want to defend your right to informed consent.

I appreciate there may be some hesitation in considering this information. We've been dare I say, indoctrinated to believe that vaccines are safe and effective; that the benefits outweigh the risks; that we have a social responsibility to vaccinate; and that without vaccines our children's lives would be at risk.

Our need to protect our children from harm makes it exceedingly challenging to consider ideas we have been told repeatedly will cause significant injury or even the death of our children.

I once thought as you do. I accepted without question the messages from conventional medical providers, the vaccine industry, politicians and the mainstream media. I trusted these individuals and organizations when they said vaccines are safe and effective and essential to ensuring the health and safety of our children.

Dare to Question

I thought this until my son Josh was permanently harmed by the DPT vaccine at five months of age. The vaccine caused significant neurological injury that Josh never recovered from. Josh lived with an uncontrolled seizure disorder and required 24-hour care for his entire life. My son never got to experience a full and healthy life.

The DPT vaccine changed both his life and mine in ways I never imagined when we consented to that first vaccination. Josh passed away in February 2017 from his vaccine related injuries. As a result of the significant neurological injuries caused by the DPT vaccine, the United States and Canadian governments eventually replaced the vaccine with the DtaP acellular pertussis vaccine, thought to be less harmful. Their action, however, was too late for my son and many others.

We all want our children to be happy, healthy and successful. After years of research I've come to the conclusion that our children's health is not dependent on injecting them with a complex mixture of biological and neurotoxic substances to artificially stimulate their immune system.

Rather, our children's health is dependent on our willingness to take responsibility for our health and that of our children, the courage to ask questions, and our ability to gather sufficient information to make well-informed decisions.

Global Effort to Eliminate Informed Consent

The fact is there is a well-organized, industry-funded effort to eliminate your right to medical decision-making and self-determination with regard to the vaccination of your children. Efforts are underway in countries around the world to remove free will and impose vaccinations on you and your children. The *Pediatric Alliance of Ontario* has openly declared this is one of their goals for 2017/18.

California, Australia, France and Italy have all recently enacted legislation to make the state the primary vaccine decision-maker and deprive parents of their right and responsibility to decide what medical interventions they will subject their children to.

If you believe vaccines really are as safe and effective as claimed, you may not have any concern with surrendering your right to medical decision-making. But if vaccines are not nearly as safe, effective or necessary, and not as evidence-based as claimed, then you may want to preserve your right to medical decision-making for yourself and your children.

Unlike the medical industry, the media and our politicians, I have no financial interest in what you decide. I only want what is best for you and your family. I only wish that your family not experience what my family experienced.

As you read through this material I anticipate you will discover there is much about vaccines and the vaccine industry you didn't know or were never told. This experience is not uncommon. Open and honest discussion about vaccine safety, effectiveness and necessity is actively discouraged. The media censors any public criticism, concern, or debate about vaccine safety and effectiveness.

But what if what we've been told isn't true? What if the science doesn't support mass universal vaccination? What if the medical community is not in unanimous agreement about the safety, effectiveness and need for vaccinations? What if the efforts to impose mandatory vaccination are motivated by financial interests rather than improved health?

What if the growing epidemic of chronic illness, immune and neurological injury, and sudden infant death are a result of the massive increase in the number of vaccines our children are exposed to? What if vaccinated children are not healthier than unvaccinated children?

The decision of whether or not to vaccinate is the most important decision you will make as a parent.

Are you prepared? Do you have enough information? Do you have solid, verifiable evidence to be confident in your decision? The challenge of vaccination is that this decision cannot be undone.

Making an Informed Choice

The vaccine paradigm is based upon an assumption that injecting a complex mixture of biological and neurotoxic substances will protect humans from infectious disease.

While there is evidence that some vaccines have been effective in the suppression of disease symptoms, the total impact of the artificial stimulation of the human immune system has not been adequately investigated and is not well understood or established.

The artificial immunization program was developed more than two hundred years ago when virtually nothing was known about the impact of injecting complex biochemical substances, foreign DNA, and toxins on organs, the neurological and immune systems, and at the cellular level.

Today, we have irrefutable evidence that the ingredients in vaccines can and do cause harm, even death. This is evidenced by the more than \$3.7 billion in compensation paid to vaccineinjured individuals in the United States by the US National Vaccine Injury Compensation Program. ¹ And we know this amount represents only a small fraction of the total number of vaccine injury victims who are rarely acknowledged, much less compensated.

As more evidence of vaccine injury is acknowledged, there is increasing consideration being given by parents and some medical professionals to modify the recommended CDC vaccine schedule. Is it reasonable to propose a modified or delayed vaccine schedule in response to vaccine injury? Or is it time to question the very basis of the artificial immune stimulation program?

This book is written by a parent and is for parents. I've spent more than thirty years reviewing the vaccine literature. 'Dare to Question' offers an overview of the many questions and concerns related to the practice of artificial immune stimulation, more commonly referred to as vaccination.

We pride ourselves on being more intelligent, more conscious and more evolved than the human beings who came before us. We find it deplorable that previous generations believed in bloodletting, lobotomy, exorcism, forced sterilization, slavery, criminalization of homosexuals, and the divine right of Kings and Queens.

Have we fully evolved? Are there no other areas of blindness, dogma, false belief, or unsubstantiated claims of what everyone 'knows to be true'? What might we accept today as truth that a future generation will find incredulous and dismiss as the thinking of a primitive species?

One practice I propose future generations will undoubtedly question is our current preoccupation with injecting a mixture of viruses, chemical preservatives, animal products, heavy metals and neurotoxins into the human body, especially our infants and children. We refer to this practice as vaccination.

Many readers will scoff at this statement. They will treat any expression of concern about the safety and effectiveness of vaccinations as the ranting of a lunatic, Luddite, anti-science fool who ought to be immediately silenced and dismissed. Such is the power of the belief in the 'miracle of vaccinations'.

The belief in vaccinations is so strong that even discussion of the issue is denied. Mainstream medicine aggressively suppresses any debate on the safety, effectiveness and necessity of vaccines. So convinced are we on the merits of vaccination that an active censorship exists to prevent giving voice to those who might entertain such 'false beliefs'.

"There is consensus in the medical community," we are told. "All vaccines are safe and effective." End of story. No further discussion or investigation is needed or desired. Allowing discussion and debate would give credibility where no credibility is due. This would be 'false balance'.

The typical messages that are routinely delivered by the pharmaceutical industry and mainstream media whenever questions of vaccine safety are raised are –

- X Vaccines are safe and effective.
- X Vaccine injury is one in a million.
- X The benefits of vaccination far outweigh the risks.
- X We have a social responsibility to vaccinate.
- X The science on vaccines is clear.
- X Vaccines do not cause autism.

Unfortunately none of these statements are scientific facts.

These statements are opinions and promotional statements.

They are propaganda masquerading as science.

Saying all vaccines are safe and effective is like saying all prescription drugs are safe and effective. The statement also implies that all vaccines are safe and effective for all people, which obviously isn't true given the US Vaccine Court has awarded more than 3.7 billion dollars in compensation for vaccine injury since 1989.

Anyone who states – "the science regarding vaccinations is clear" is not a scientist, nor being honest.

The undisputed facts are the following:

- There are no long-term clinical trials that prove vaccine safety.
- Most effectiveness trials are limited to the measurement of anti-bodies in the blood rather than producing verifiable evidence that the vaccine actually prevented the targeted disease.
- No safety trials exist that determine the safety of giving multiple vaccinations at once.
- No large safety trials using an unvaccinated population as the control group have proven that vaccines are safe and effective.
- The current vaccine schedule has never been tested for safety in the real world way in which the schedule is implemented.
- No clinical proof exists to support the claim that vaccines are responsible for the decline in mortality, let alone the claim of millions of lives saved.
- There are no clinical studies that show injecting mercury into humans is safe in any amount.
- The amount of aluminum used in vaccines regularly exceeds the maximum amount permitted by the FDA.

Unfortunately facts are not part of the discussion because there is no discussion. Vaccination is effectively a religion. Doctors and the pharmaceutical industry are the new high priests. It is blasphemy to question the edicts of the high priests. The punishment for questioning is being silenced, ostracized and banished.

Everyone must believe. Anyone who does not believe is deemed a threat to the community. Fear of damnation is used to coerce compliance with the prevailing dogma. Laws must be put in place to secure the compliance of those who do not believe.

Parents in California are no longer able to decide what is injected into their children without forfeiting their right to a public education. This means children in California do not belong to their parents. Children are the property of the State.

The strength of this dogma will be evident in the emotional response to this essay. Many will immediately dismiss what is presented here. The dismissal will not be based on verifiable scientific evidence. It will not be based on well-designed and critically evaluated clinical trials of safety and effectiveness. Rather the dismissal will be based on a *belief* of what everyone knows to be true. No evidence is required to confirm what everyone already knows to be true.

Then in some future time when a shift in consciousness occurs, the thought of injecting toxins into our infants and children will be viewed as highly irresponsible and relegated to the mysteries of a primitive species alongside bloodletting, the superiority of one race over another, and the belief that we are the centre of the universe.

Many Parents Question Vaccines

You might reasonably wonder if you are the only parent questioning vaccine safety and effectiveness. The mainstream media intentionally marginalizes people who question vaccine safety and effectiveness with labels like: anti-vaccine, anti-vaxxer, anti-science, irresponsible, misguided, uninformed, etc.

The fact is there are many parents who are questioning vaccine safety, effectiveness and necessity. The medical journal, *Pediatrics*, reports:

The number of pediatricians encountering parents who question vaccine safety, refuse one or more vaccines, or want to use an alternative vaccination schedule increased from just under 75% in 2006 to 87% by 2013. ¹

The number of parents questioning the safety, effectiveness and necessity of vaccines is even higher today.

Is Questioning Vaccine Safety New?

Concern about vaccine safety and the loss of the right to informed consent and self-determination is not new.

In the 1800s, there was public criticism of the smallpox vaccine. People objected for the same reasons as they do today, on the basis of scientific, religious, political and health concerns.

In 1853 in Victorian England, *The Vaccination Act* introduced mandatory vaccination of infants. There was immediate resistance. Parents demanded the right to control their bodies and those of their children. Anti-mandatory vaccination organizations were formed to end forced vaccination.

Its Not Just Parents Questioning Vaccines

And it's not just parents who are questioning the safety, effectiveness and necessity of vaccines. Other organizations and professional bodies are challenging the claims of the Centre for Disease Control and the pharmaceutical industry.

Public health officials and the medical profession have abrogated their professional, public, and human responsibility, by failing to honestly examine the iatrogenic harm caused by expansive, indiscriminate, and increasingly aggressive vaccination policies.

On a human level, the documented evidence shows a callous disregard for the plight of thousands of children who suffer irreversible harm, as if they were unavoidable "collateral damage". The corrupting influence of the pharmaceutical industry on medical research and its published literature, has derailed the medical profession from its humanitarian mission and its professional objectivity. ²

Many physicians have come together to form 'Physicians for Informed Consent'. Their vision is to - "Live in a society free of mandatory vaccination laws."

These physicians recognize that mandatory vaccination laws threaten our health, our rights and our liberty. *Physicians for Informed Consent* is a member of a coalition of more than 70 local, national and international organizations that recognize the importance of informed consent and are dedicated to protecting and preserving that right.

Physicians for Informed Consent is not ideologically pro-vaccine or anti-vaccine. Rather, they are pro-health, pro-ethics and pro-informed consent in vaccination, as in any other medical procedure.

Informed consent involves the basic human right to consent or refuse a medical treatment or procedure, including vaccination.

The consent must be voluntary.

If a patient, or parent of a patient, is coerced or threatened in any way into consenting for vaccination (including statutory or government mandated exclusion from school), then the "consent" obtained is actually coerced consent, not informed consent.

Why Isn't This Information Reported in the Media?

This is a good question. The short answer is – 'follow the money'. The mainstream media rely on advertising revenues to stay in business. The pharmaceutical industry is one of the largest sources of advertising revenues today.

Robert F. Kennedy Jr. reported that in a non-election year in the United States, mainstream news programs receive 70% of their advertising revenues from the pharmaceutical industry. A top-level television executive admitted to Kennedy that he would dismiss any producer who aired a program that put their pharmaceutical advertising revenues at risk.

There is intense pressure exerted on media, including social media (Google, Facebook, Pinterest), to censor vaccine concern and criticism. Seth Berkley, director of GAVI, an international alliance of vaccine manufacturers has called for "anti-vaxxers" to be banned from all social media.

The vaccine industry hires 'internet trolls' who literally troll the Internet to mock and vilify anyone who expresses concern about vaccine safety, effectiveness or necessity. These industry trolls undermine our right to freedom of speech.

Vaccine Safety Science is Hazardous

Scientists examining vaccine safety report they are routinely attacked because of their efforts to investigate vaccine safety. These authors state that, rather than the science being critiqued, they are being attacked personally. This sends a chilling message to scientists that vaccine safety and effectiveness is not to be investigated or questioned. They state this aggression makes vaccine safety science a "hazardous occupation".

Doctors also report being challenged by their own professional organizations when they question vaccine safety, report adverse events following vaccination, or write medical exemptions for their patients. The message is – "Don't question vaccines." ³

"Recently, the authors of many vaccine safety investigations are being personally criticized rather than the actual science being methodologically assessed and critiqued. Unfortunately, this could result in making vaccine safety science a "hazardous occupation".

Critiques should focus on the science and not on the authors and on the scientists that publish reasonably high-quality science suggesting a problem with a given vaccine.

These scientists require adequate professional protection so there are not disincentives to publish and to carry out researches in the field. The issues for vaccine safety are not dissimilar to other areas such as medical errors and drug safety." 4

These attacks are not unique to vaccines. We witnessed these same tactics with other health and safety concerns including:

- Smoking and lung cancer
- Mercury in dental fillings
- Fluoride in water
- Lead in gasoline and paint
- Food irradiation
- Arsenic, DDT, and other pesticides
- Genetically Modified Organisms
- Thalidomide, Vioxx, Oxycontin

Immunization is a complicated topic that needs more reflection and less coercion. It's time to realize that vaccines, like medicines, are not a mystic panacea and that they are subject to the commercial and political pressure and also to the influence of conflicts of interest.

18 Facts About Vaccines

The following are 18 facts about vaccines that every parent should be aware of:

Fact 1: Mandatory vaccination violates the medical ethic of informed consent, the Nuremberg Code, and the Universal Declaration of Bioethics and Human Rights.

Fact 2: The United States and Canada have the most aggressive vaccine schedules in the world. The number of recommended vaccines in the US and Canada have more than doubled since 1980. Children can receive as many as 53 doses of 15 vaccines by age 6. ¹

Fact 3: Canada is the only G7 nation without a national vaccine injury compensation program. ^{2 3} If your child is injured by a vaccine in Canada, you are on your own.

Fact 4: The safety of the current CDC vaccine schedule has **never been proven** in large, long-term clinical trials. ⁴⁵ There is increasing evidence that the risks of vaccination outweigh the benefits.

Fact 5: Vaccines have **not been tested** for their ability to cause cancer, the degree to which a vaccine can damage an organism, their ability to damage genetic information, their ability to change genetic material, or for long-term adverse reactions. Product monographs make this fact clear. 6

Fact 6: The current vaccine schedule has **never been tested** for safety in the real world way in which the schedule is implemented.⁷

Fact 7: No independent trials confirm the safety of giving multiple vaccinations at once. Research shows a dose-dependent association between the number of vaccines administered at the same time and hospitalization and death. ⁸

Fact 8: No long-term clinical evidence exists that show vaccinated children have better overall health than unvaccinated children. ^{9 10}

Fact 9: There are **no clinical studies** that show injecting mercury into humans is safe. There is irrefutable evidence that the use of mercury in vaccine production increases the risk of neuro-developmental disorders. ¹¹ ¹² ¹³ ¹⁴ ¹⁵

Fact 10: No clinical studies have been conducted to establish the safety of using aluminum in vaccines. The neurotoxicity of aluminum is well documented, affecting memory, cognition and psychomotor control, and causes damage to the blood brain barrier. ¹⁶

Fact 11: The amount of aluminum used in vaccines **regularly exceeds the maximum** amount permitted by the FDA. ¹⁷ Two month old babies in Canada, the U.K., U.S and Australia are exposed to **49 - 54 times** the current safety limit for aluminum exposure.

Fact 12: Most vaccine safety trials use control groups consisting of other vaccinated populations or placebos containing aluminum. **These are not true placebos**. ¹⁸

The failure of the pharmaceutical industry to use a neutral placebo undermines the integrity of CDC claims that vaccines have been proven to be safe and effective. ¹⁹

Fact 13: The US Vaccine Court has awarded more than **3.7 billion dollars** in compensation for vaccine injuries and death since 1989. ²⁰ This includes families whose children developed autism following vaccination. ²¹

Fact 14: Artificially stimulated immunity via vaccines **is not life long**. Disease outbreaks regularly occur in fully vaccinated populations. ²² ²³ ²⁴ ²⁵ The need for booster shots makes this self-evident.

Fact 15: Vaccine pre-license safety trials are not conducted by the government. They are conducted by the vaccine manufacturers who are immune from **liability** for the safety of their products.

Fact 16: Vaccine producers Merck and GlaxoSmithKline have **paid billions in criminal penalties** and settlements for research fraud, faking drug safety studies, failing to report safety problems, bribery, kickbacks, and false advertising. ²⁶ ²⁷

Fact 17: The disclosures by CDC senior scientist, Dr. William Thompson, reveal the CDC has known for more than fifteen years that children receiving the MMR vaccine on schedule **are significantly more likely to regress into autism** compared with children whose parents decided to withhold the vaccine until the child was older. ²⁸ ²⁹ ³⁰

Injecting Viruses is Unnatural

It's important for parents to understand that the practice of injecting viruses and foreign substances into the human body is unnatural.

- Sodium chloride (table salt) 54,100 mcg
- Sodium citrate (food additive) Unknown amounts
- Sodium hydroxide (Corrosive) Unknown amounts
- Sodium phosphate- 2,800 mcg
- Sodium phosphate monobasic monohydrate (toxic) Unknown amounts
- Sorbitol (Not to be injected) 32,000 mcg
- Streptomycin (antibiotic) 0.6 mcg
- Sucrose (cane sugar) Over 40,000 mcg
- Yeast protein (fungus) 35,000 mcg
- Urea (metabolic waste human urine) 5,000 mcg

The CDC's repeated assurances that all of these ingredients are safe are hardly persuasive or even credible, since they have failed to provide any evidence of the slightest attempt to investigate them.

Vaccines Contain Neurotoxins

Mercury: Vaccine manufacturers use mercury (Thimerosal) in the production of many vaccines, and as a preservative in multi-dose vials of the influenza vaccine. Mercury is recognized as the most toxic substance that is not radioactive.

The acceptable limit of mercury in drinking water in Canada is 1 parts per billion. In the US it is 2 ppb. A liquid with 200 ppb is considered toxic waste. Several brands of the infant influenza vaccine have 25,000 ppb. Many of the regular influenza vaccines have 50,000 ppb of mercury.

It is scientific fact that human brain neurons permanently disintegrate in the presence of mercury. There is no evidence injected mercury is safe in any amount. ²³⁴⁵⁶

In fetuses, infants and children, low-dose exposure to mercury can cause severe and lifelong behavioural and cognitive problems. At higher exposure levels, mercury may adversely affect the kidneys, the immune, neurological, respiratory, cardiovascular, gastrointestinal, and haematological systems of adults. ⁷

Aluminum: Aluminum is another neurotoxin used in vaccines. Aluminum has never undergone biological testing to determine whether it is safe. Aluminum, like mercury, was 'grandfathered' into our medical system without the benefit of safety testing.

Aluminum affects memory, cognition and psychomotor control and causes damage to the brain. Clinical evidence indicates aluminum is a primary etiological factor in dementia and Alzheimer's disease. Aluminum also interferes with gene expression and depresses mitochondrial function.

The amount of aluminum in many vaccines exceeds the maximum amount permitted by the FDA. 89

A 2017 aluminum toxicity study conducted by Christopher Exley Ph.D., a world-renowned aluminum expert found:

Some of the highest quantities of aluminum ever recorded in the brains of autistic boys. ¹⁰

Vaccines Contain Harmful Ingredients

Vaccines contain known neurotoxins, chemically altered viruses, antibiotics, preservatives, detergents, stabilizers, neutralizers, carrying agents, Polysorbate 80, MSG, formaldehyde, glyphosate, genetically modified viruses, and other harmful ingredients which counteract and/or bond synergistically thereby increasing their potential harm. ¹¹ ¹²

Mercury and other heavy metals adversely affect the gastrointestinal, immune, nervous and endocrine systems. Heavy metals alter cellular function and numerous metabolic processes in the body, including those related to the central and peripheral nervous systems. ¹³

Vaccines Contain Animal DNA/RNA

Animals and insects are used in the manufacture of vaccines. Animals used include: monkey, cow, chicken, duck, pig, sheep, dog, horse, rabbit, guinea pig and mice.

The medium in which vaccine bacteria and viruses are cultivated include: rabbit brain tissue, dog kidney tissue, monkey kidney tissue, chicken or duck egg protein, chick embryo, calf serum and pig and horse blood. Animal tissues naturally contain animal DNA/RNA and viruses.

Dare to Question

Animal viruses have the ability to implant their genetic material into the human genetic system. Animal proteins and viruses are foreign to the human body.

The animal DNA/RNA and viruses cannot be fully screened out during the manufacturing process.

Most vaccines are contaminated with a number of known and yet-to-be discovered viruses, bacteria, viral fragments and DNA/RNA fragments. Once animal DNA, viruses and retroviruses insert themselves into human cells, they cannot be removed. The injection of animal DNA/RNA compromises the biological integrity of the human race.

Unlike chemical pollutants which break down and become diluted out, retroviral nucleic acids are infectious, they can invade cells and genomes, multiply, mutate and recombine indefinitely.

Injecting animal viruses and retroviruses into humans is creating unknown new diseases and chronic illness. 14

Vaccines Derived From Aborted Fetuses

Many live virus vaccines (measles, mumps, rubella, chicken pox, shingles) are grown in cell lines derived from aborted human fetuses. These include WI-38, cell cultures from a female fetus that was aborted in 1964, and MRC-5, cell cultures from a 14-week male fetus that was aborted in 1966. ¹⁵

In addition to the clearly ethical and religious considerations of using aborted humans to grow vaccine viruses, these cell lines contain human DNA debris. Research indicates a causal relationship between vaccines manufactured using fetal cell-lines and the prevalence of autism spectrum disorder. ¹⁶

Vaccines Affect Brain Development

During these early years, a baby's developing brain is particularly vulnerable to environmental toxic exposures. We recognize this with the risk of drinking alcohol during pregnancy. We know that cellular structures change rapidly during fetal growth and the early years, and that a toxic exposure at the wrong moment can permanently damage the brain.

One mistake early on, and the brain may be forever changed in subtle or serious ways.

It is not just toxic exposures from the external environment that threaten normal brain development. It's imperative we also recognize the risks of injecting highly inflammatory neurotoxic substances like aluminum into our infants during critical windows of brain growth.

Researchers are now discovering that aluminum adjuvants in vaccines can be transported into the brain and provoke ongoing chronic brain inflammation. With the current CDC vaccination schedule high quantities of aluminum are injected into an infant's fragile micro-environment during these highly sensitive early years of brain formation.

In the early years, in order to protect the developing brain during rapid brain growth, the baby's immune programming requires that it be in a non-inflammatory state. The key to insuring normal brain development is to protect the baby's immune system from anything that causes inflammation. ¹⁹

If the immune system is provoked early on by inflammation, the normal course of brain development can be negatively impacted.

We now know that the brain has its own immune cells (the microglia), which play a crucial role in brain development. These immune cells are highly sensitive to inflammation. Vaccinations, by design, creates inflammation which then triggers the microglia to secrete highly toxic chemicals that can lead to a chronically inflamed state in the brain resulting in the destruction of connective synapses. ^{20, 21}

Immune activation triggered by infections or vaccines damage the growing brain.

This can result in life-long brain injuries, ADHD, mental illnesses, seizures/epilepsy, schizophrenia and autism. A large field of study has identified that cytokines, triggered by excessive immune activation, are involved in brain injury leading to autism. ²²

No clinical studies have been conducted to establish the safety of aluminum adjuvants in infants and children.

The scientists at *Vaccine Papers* extensively discuss the impact of inflammation on the brain during fetal and early life brain development. ²²

In particular, aluminum in adjuvant form carries a risk for autoimmunity, long-term brain inflammation and associated neurological complications and may thus have profound and widespread adverse health consequences. ^{23,24}

Science Has Been Corrupted

Vaccine Herd Immunity Is Unproven

The promise of herd immunity is used to coerce legislators, doctors, public-health officials, medical personnel and the public into accepting forced vaccinations. What is not commonly known is that herd immunity is a *theory* based on *natural* infection, which in most cases provides lasting, long-term immunity.

The immune response stimulated by vaccines is temporary, lasting a few years or even as short as a few months. ² There is insufficient evidence to conclude that artificial immune stimulation can ever create herd immunity.

The Tdap and MMR vaccines are good examples of the failure of vaccines to produce herd immunity. Based on the peer-reviewed published efficacy, at any given point in time only 5% of Americans have some sort of vaccine-induced immunity to pertussis, and 12% have full to half-immunity to measles. ³

The herd immunity we enjoy today is provided by the generations born before 1960 that experienced natural disease exposure. These individuals provide real herd immunity. Without the mantra of herd immunity, public-health officials and politicians would not be able to justify forced mass vaccinations and the loss of individual rights and freedoms.

If vaccinations worked as their proponents claim, it wouldn't make any difference to the vaccinated whether anyone else was vaccinated or not.

No parent should be pressured to vaccinate on the basis of speculation of vaccine induced herd immunity, or to risk his or her child's health in the hope it may protect someone else's child. The conflict between private and public rights contradicts the claims made by vaccination proponents.

Most Vaccines Don't Prevent Infection

What is also not commonly known is that most vaccines do not prevent infection or transmission of disease.

Five vaccines – polio, diphtheria, influenza, pertussis, and tetanus are not designed to prevent infection or transmission of disease. They are designed only to reduce the severity of symptoms should one become infected.

Four vaccine targeted diseases – tetanus, Hepatitis B, HPV, and Meningococus are not communicable through casual contact and therefore not easily transmitted.

Three of the vaccine targeted diseases – Pneumococcus, Influenza, and HPV have so many strains that vaccination does little to reduce the prevalence of the disease. Vaccination actually causes an increase in the strains not covered by the vaccine.

The fact is an individual who is not vaccinated with polio, diphtheria, tetanus, whooping cough, Hep B or Hib poses no extra danger to the public than a person who is. 456789

To imply that non-vaccinating individuals are a threat to the community is marketing propaganda, not evidence-based medicine. It is fear mongering, not science.

Vaccination Is an Uncontrolled Experiment

The gold standard of safety research compares a subject group with a control group. A true clinical trial utilizes a placebo – a substance that is known to be neutral or harmless.

Most vaccine safety trials use other vaccinated populations or placebos containing aluminum as the control group.¹⁰ Neither of these are neutral placebos. In fact, not a single one of the clinical trials for vaccines given to babies and toddlers had a control group receiving a neutral placebo.

Vaccine safety trials that are conducted without a neutral placebo cannot determine if a product is safe.

Many pre-licensure trials do not include patient populations most at risk of serious adverse events. This is not responsible science. In fact, this is not science.

Vaccines given in the combination schedules recommended for our children today have never been tested for safety, which makes this practice a medical experiment. Vaccination is an uncontrolled experiment upon our infants and children.

Vaccine safety "science" is not recognizable as science anymore.

The Claim That There is No Connection Between Vaccines & Autism Is Dishonest

It is unscientific and perilously misleading for the *Centre for Disease Control* to assert that vaccines and autism have been exhaustively studied and that no connection has been found.

While there are 16 or so industry-funded studies that are regularly cited by critics of the vaccine-autism hypothesis, these studies examine only one vaccine product (MMR) and one vaccine ingredient (Thimerosal).

It is illogical to exonerate all vaccines, all vaccine ingredients, and the total vaccine program based on a handful of epidemiological studies of just one vaccine product and one vaccine ingredient.

The studies used to deny a vaccine-autism link include the 2004 study which senior CDC scientist Dr. William Thompson revealed the CDC fraudulently withheld data with the express intention of misleading the public about the vaccine-autism link. This alarming disclosure is the basis of the 2016 documentary -*Vaxxed: From Cover-Up to Catastrophe*.

CDC funded studies conducted by Dr. Poul Thorsen used intentionally misleading data for the sole purpose of denying a link between vaccines and autism. ¹¹ Thorsen is a wanted felon in the United States.

The remaining studies have been widely criticized in the scientific community for their lack of statistical power and design. None of the studies compares the rate of autism in an unvaccinated population with a vaccinated population. It would appear these studies were intentionally designed to <u>not</u> find a vaccine-autism connection. This is not science. This is propaganda masquerading as science.

Compelling Evidence that Vaccines Cause Autism

There is compelling evidence that a vaccine-autism connection exists:

There are now more than 144 independent research studies ¹² that show a relationship between vaccination and autism. And more evidence is being uncovered every day.

A report in the *Pace Environmental Law Review Journal* reviewed 83 cases of vaccine-induced brain injury that resulted in an autism diagnosis, which were compensated by the U.S. Federal Vaccine Injury Compensation system. ¹³

Award-winning journalist, Sharyl Attkisson, investigated the vaccine-autism link and compiled an extensive list of studies that show a vaccine-autism link - *What the News Isn't Saying About Vaccine-Autism Studies* – updated November 27, 2016. ¹⁴

Attkisson concluded -

The body of evidence on both sides is open to interpretation. People have every right to disbelieve the studies on one side. But it is disingenuous to pretend they do not exist.

Dr. Bernadine Healy, the former head of the *National Institutes* of *Health*, stated that the vaccine-autism link is not a "myth". Dr. Healy disclosed that her colleagues at the Institute of Medicine did not wish to investigate the possible link between vaccines and autism because of the impact they feared it would have on the vaccination program.

The failure to fully investigate the vaccine-autism link indicates the vaccine program is ideology and dogma rather than science.

It became clearer to me as I read the research, listened to more and more parents, and found other practitioners who also shared the same concern that vaccines had not been completely proven safe or even completely effective, based on the literature that we have today.

It didn't appear that the scientific studies that we were given were actually appropriately designed to prove and test the safety and efficacy.

It also came to my attention that there were ingredients in there that were not properly tested, that the comparison groups were not appropriately set up, and that conclusions made about vaccine safety and efficacy just did not fit the scientific standards that I was trained to uphold in my medical school training. ¹⁵

Is Measles A Manufactured Crisis?

A few years ago a medical crisis was declared in Canada. The result was a tremendous outpouring of anger, resentment and judgment. People were called names. Consideration was given to removing a parent's right to make medical decisions for their children. Some even advocated for removing the children from those parents who didn't comply with the proclaimed action needed to ward off the impending medical crisis.

The crisis that triggered this outpouring of fear, anger and judgment – an outbreak of measles.

The media was incredibly vigilant in reporting every single case of measles. At last count there were 375 cases reported in British Columbia, 6 in Calgary, 1 in Edmonton, 11 in Regina and 11 in Ontario (*Huffington Post*, April 13, 2014).

Individuals of my generation are a bit mystified by the intensity of the purported crisis. As someone who grew up in the 1960's, everyone I knew contracted measles at some point in his or her childhood. Everyone also understood that getting measles in childhood provided long-term immunity. Now, a measles outbreak results in a reaction as intense as the SARS crisis of a few years ago, or the AIDS epidemic even prior.

How did this common and benign childhood event become so threatening that normally kind and well-intended individuals felt justified to treat others badly? How did measles become the basis for depriving individuals of their rights and freedoms?

Two colleagues shared with me the impact of this purported crisis on their lives. One, the mother of a four year old, informed me that she finally succumbed to having her daughter vaccinated for measles after a barrage of phone calls day after day insisting that she "do the right thing and get her daughter vaccinated." "You won't be able to live with yourself if your daughter gets measles," she was informed.

The second, another mother, shared with me the following:

"Hey, there's a measles outbreak! Have you heard? It's got just a wee bit of media attention. I'm having a difficult time filtering out the unkind things people have to say about people who do not vaccinate. Selfish. Should be kept in a bubble, sent to an island, and excluded from society. Stupid. Negligent. It's amazing how nasty people can be, and how it is apparently okay to be unkind about parental choices when the topic is vaccination."

I've received my own dose of unkind words and judgments when I've attempted to defend the rights of parents to make an informed decision regarding vaccination.

CTV News reporter Jon Woodward holds people like me responsible for the reduction in vaccination rates in his commentary – 'BC Vaccination Rates Drop Amid 'Misinformation campaign'. Woodward is typical of most media pundits in his assessment that I am the one who is "misinformed". Woodward's failure to provide or demand any evidence of the safety and effectiveness of the measles vaccine is not considered relevant.

The *National Post* conducted a survey to elicit opinions on whether vaccinations ought to be mandatory and thus deny a parent the right and responsibility to choose what is in their children's best interest.

Not surprisingly, given the bias in the media's reporting of this complex topic, the majority of Canadians responding to this survey supported denying a parent the right to make this medical decision.

This event is similar to numerous other events in recent years. Witness the reporting on 9/11 and the need for an invasion of Iraq and Afghanistan. We were inundated with information that was purported to be true by well-informed 'experts'. Remember those weapons of mass destruction? Some kind of urgent action is needed, we were told. There is no time to think. There is no time to discuss the matter. Anyone who does not respond as demanded is irresponsible, selfish, delusional and dangerous.

Psychologists understand how it is that we are so easily coerced into a reactive response. They describe the process as 'Problem – Reaction – Solution'. A problem is manufactured. A reaction is elicited. And a solution is offered. Witness the recent events: measles outbreak = crisis = this is terrible and something must be done = take away a parent's right to voluntary, informed consent.

We would be wise to be more discerning in how we can be coerced into making reactive decisions rather than thoughtful and well-informed decisions. We ought to be especially sensitive to situations where we are emotionally hijacked, then told an immediate action is needed without the benefit of thoughtful discourse. These reactive actions undermine our capacity to use our gifts of intelligence and compassion.

We all deserve better. The answer will not be in the way mainstream media reports these issues. Rather the answer will be our unwillingness to become easily manipulated and coerced into supporting a reactive response. In this fear-based scenario, the questioning voice of reason is drowned out amid the hysteria surrounding the emerging 'killer infections', which are such a favorite media topic.

The propagation of fear by the media and by its sources in the public health industry has resulted in a growth of power in this industry far beyond the usual checks and balances of our democracy. ¹

Vaccination Distorts Public Health Priorities

These public health measures were responsible for the significant decrease in mortality and the increase in health in the last century, not vaccinations. Quarantine was very effective during small pox epidemics.

Public health agencies are ignoring these effective health measures and have mistakenly identified 'increased vaccine uptake' as the desired outcome rather than 'improved health'.

When trying to achieve any goal, it is important to measure the correct outcome. Our goal should be improved health.

Vaccination Policy is Anti-science

Vaccination has become politicized such that honest debate is no longer permitted. The active censorship of concern about vaccine safety, effectiveness and necessity eliminates an important safeguard and increases our vulnerability to being harmed.

Stating that, "All vaccines are safe and effective" is like saying "All prescription drugs are safe and effective". Such statements are without scientific integrity and are meaningless. In the vaccine science domain much of what claims to be science is not scientific at all. Censoring discussion about vaccine safety, effectiveness and necessity is anti-science and anti-democracy.

Vaccination Is Not a Medical Issue

Vaccination is not a medical issue. Rather vaccination is a financial and ideological issue disguised as a medical issue.

If vaccinations were truly a medical issue there would be more interest in whether vaccines were safe, whether they prevented the targeted illnesses, and whether the health of those receiving vaccines was better than those who did not.

The reality of the vaccine program becomes evident when we witness the amount of financial and human resources dedicated to promoting vaccines and tracking vaccine compliance, rather than tracking vaccine safety and effectiveness.

The virtual absence of interest in vaccine safety and effectiveness is a strong indication that the intention of the vaccination program is not improved health.

Vaccine Policy Undermines Rights and Freedoms

Vaccine policy violates our rights and freedoms as citizens and erodes our parental rights and responsibilities to make medical decisions for our children.

Efforts to increase vaccine compliance include coercion, financial incentives and disincentives, punishment, restriction to education, childcare and employment, even imprisonment.

If the State can tag, track down and force individuals to be injected with biologicals of known and unknown toxicity today, then there will be no limit on which individual freedoms the state can take away in the name of the greater good tomorrow.

Mandatory vaccine policy is a clear and direct violation of the Nuremberg Code, developed in response to the medical experimentation conducted by the Nazis, as well as a violation of the Universal Declaration on Bioethics and Human Rights; Article 6 – Consent: ¹

The US Vaccine Injury Compensation Program has awarded more than \$3.7 Billion for vaccine injury since 1989. ²

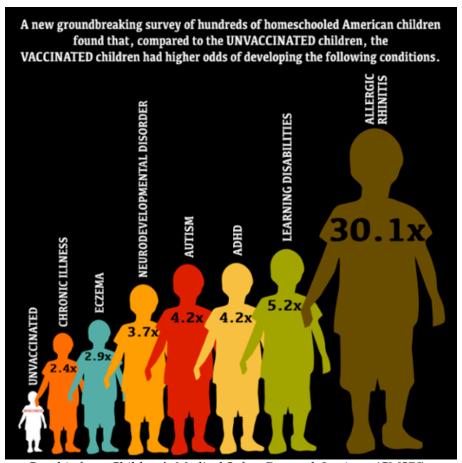
Every G7 Nation, excepting Canada, has a national vaccine injury compensation program. These Nations recognize vaccines cause injury and death and compensate for significant injury and death.

No Evidence Vaccinated Individuals Are Healthier

The *Journal of Translational Science* published the first independent, non-industry funded study comparing the overall health of vaccinated and unvaccinated 6 to 12 year old children in the United States. ³

The results of the study reveal that while vaccinated children were significantly less likely to have chicken pox or whooping cough, they were significantly more likely to have pneumonia, allergies, otitis media (ear infection), eczema, a learning disability, Attention Deficit Hyperactivity Disorder (ADHD), Autism Spectrum Disorder, neuro-developmental disorders, and chronic illness.

No significant differences or benefits were seen with hepatitis A or B, measles, mumps, meningitis (viral or bacterial), influenza or rotavirus.

A 2012 vaccine study reported a linear relationship between the number of vaccine doses administered at one time and the rate of hospitalization and death. ⁴

The results also showed that the younger the infant at the time of vaccination, the higher the rate of hospitalization and death.

The safety of CDC's childhood vaccination schedule was never affirmed in clinical studies. Health authorities have no scientific data from synergistic toxicity studies on all combinations of vaccines that infants are likely to receive.

National vaccination campaigns must be supported by scientific evidence. No child should be subjected to a health policy that is not based on sound scientific principles and, in fact, has been shown to be potentially dangerous. ⁵

There is no substantive evidence that children receiving the current vaccine schedule are healthier than those who don't.

Vaccine Manufacturers Not Accountable for Safety

Many parents are not aware that the vaccine industry in the United States is not legally liable for the safety of their products. The vaccine industry was granted legal immunity by an act of the US Congress in 1986. The nuclear industry is the only other industry that is not legally responsible for the harm their products cause.

The result of this legal immunity is that no one can be held responsible for the injuries and deaths caused by vaccination.

This freedom from liability includes not only the vaccine manufacturers, but also government agents in the CDC and FDA, and those who encourage, license and administer vaccines including doctors and nurses.

A consequence of this legal immunity is there is no legal or financial incentive for the pharmaceutical industry to make vaccines safer, even when there is evidence that vaccines can be made safer. This creates a very dangerous situation. The vaccine industry has effectively been given license to injure and kill with impunity. There is evidence that the legal immunity provided to vaccine manufacturers has increased the risk of harm. ⁶

This legal immunity was not designed to protect citizens. It was designed to protect the pharmaceutical industry.

It's nothing but hubris that allows scientists to ignorantly think they can imitate natural immunity by injecting scores of foreign substances into human beings to raise targeted antibody levels without disrupting or destroying cells, tissues, systems, and processes.

Vaccine Schedule Not Tested for Safety

One of the major criticisms of the vaccine industry is its failure to conduct long-term clinical trials that prove the safety of the current vaccine program. ⁷⁸⁹

The prestigious *Institutes of Medicine* (IOM) found that the safety of the current childhood vaccine schedule has never been proven in large, long-term clinical trials:

Few studies have attempted more global assessment of entire sequence of immunizations or variations in the overall immunization schedule and categories of health outcomes, and none has squarely examined the issue of health outcomes and stakeholder concerns in quite the way that the committee was asked to do its statement of task. None has compared entirely unimmunized populations with those fully immunized for the health outcomes of concern to stakeholders. ¹⁰

Vaccines have not been tested for the ability to cause cancer (carcinogenicity); the ability to damage an organism (toxicity); the ability to damage genetic information within a cell (genotoxicity); the ability to change the genetic information of an organism (mutagenicity); the ability to impair fertility; and for long-term adverse reactions.

Most vaccines currently on the market have been approved based on studies lasting only a few weeks or days. ¹¹

For a vaccine to be administered without adequate safety data is nothing short of medical malpractice.

Adequate human data on use during pregnancy are not available.

Vaccination Increases Infant Death

A study comparing the rate of vaccination with the rate of infant mortality in first world countries identified a relationship between the number of vaccines given in the first year of life and the rate of infant mortality. The more vaccines given, the higher the rate of infant death. ¹² The United States and Canada have a higher rate of infant mortality than some third world countries.

The United States, which vaccinates newborns and has the most aggressive vaccination schedule in the first year of life in the world, has the highest infant mortality rate of any developed country in the world. ¹³ ¹⁴ Canada, which is second in the number of vaccines given in the first year of life, is ranked 28th in infant mortality (2009 infant mortality rates).

In an urban African community, a study found that the DTP vaccine is associated with a five-times higher mortality than children unvaccinated with DTP. No study has shown beneficial survival effects of the DTP vaccine. ¹⁵

In July 2017, the U.S. Court of Federal Claims ruled that there was "preponderant evidence" supporting the claim that vaccines "actually caused or substantially contributed" to Sudden Infant Death Syndrome (SIDS). ¹⁶

Multiple Vaccine Exposure Increases Risk

The current vaccine schedule recommends multiple vaccine injections at one time. In nature, the human body is not subject to multiple disease agents, toxic chemicals, foreign DNA and retroviruses at one time.

There are no studies examining the synergistic effects of giving multiple injections at once.

Exposure to multiple infectious agents and the accompanying toxic ingredients via injection increases the likelihood of a compromised immune system, making the infant more vulnerable to illness, serious adverse reactions and death. ¹⁷

Multiple injections place an unnatural and unnecessary burden upon the immune system and compromise its ability to work effectively. Every new vaccine added to the schedule increases the complexity and the risk of adverse reactions.

Evidence of Effectiveness Is Not Required

Most individuals lose their elevated antibody levels two to ten years after being vaccinated. Approximately ten percent of the population has no increased antibody response to a vaccine. At any given time a significant portion of the population has no increased antibodies to the diseases they had been vaccinated against. The absence of disease outbreaks begs the question of whether vaccines are necessary.

Vaccine manufacturers are not required to demonstrate vaccines actually reduce the rate of disease contraction, contagion, complication or mortality. It is simply assumed that elevated antibody levels equate to immunity, despite the lack of supporting evidence.

Vaccines are the only medication where evidence of effectiveness and absence of harm are not required before approval. This is especially evident with the HPV vaccine.

There is no clinical evidence the HPV vaccine has prevented anyone from contracting cervical cancer.

Vaccine efficacy ought to be evaluated based on clinical evidence the vaccine actually increased disease prevention and improved health. This does not occur with the vaccine program.

Vaccines Spread Disease

Live-virus vaccines spread disease through viral shedding. Live-virus vaccines include: measles, mumps, rubella, nasal flu, shingles, rotavirus, chicken pox, oral polio and yellow fever. ¹ Vaccine strain live-virus can be shed in body fluids such as saliva, nasal and throat secretions, breast milk, urine and blood, stool and skin lesions.

Shedding after vaccination may continue for days, weeks or months depending on the vaccine and the individual.

Vaccinated individuals risk spreading disease every time they are re-vaccinated. Vaccinated individuals can also be infected, yet remain asymptomatic thereby unknowingly spread the disease. Viral shedding is the reason recently vaccinated individuals are not permitted to visit hospital wards of cancer and immune suppressed patients.

Vaccines Eliminated Herd Immunity

The vaccine program has effectively eliminated herd immunity. Vaccinated individuals do not have life-long immunity to infectious diseases. In the developed world, herd immunity no longer exists and hasn't since the 1960s. The vaccination program has extinguished the widespread herd immunity that benefited the majority of people due to natural exposure to measles, mumps, whooping cough, rubella and chicken pox.

The introduction of mass vaccinations has drastically changed the natural and safe pattern of disease experience.

Infants were protected from diseases by maternal immunity. Adults were protected by their own permanent immunity, which nearly all of them acquired in their childhood via the disease experience. Mild childhood diseases have now been pushed into infancy and adulthood where they have more serious consequences.

Vaccines do not protect us for a lifetime. They only postpone the susceptibility to the corresponding infection rather than extinguish the susceptibility completely. No one knows when the vaccine's protective effect expires. This uncertainty increases the risk of contracting 'vaccine preventable diseases'.

Vaccination Increases the Risk to Infants

Vaccination reduces the maternal antibody protection transferred from a mother to her newborn. ^{2 3} The result is the infant of a vaccinated mother is more at risk of infectious disease earlier in life than the infant of a mother with naturally acquired immunity.

Disrupting the natural cycle of the mother-infant immunity transfer is a dangerous and irreversible consequence of prolonged vaccination campaigns. The vaccine paradox is that while vaccines may reduce the incidence of disease in childhood, they put the next generation of infants more at risk.

Humanity is now dependent upon artificial immune stimulants for temporary protection.

This dependence results in three critical health concerns. Firstly, vaccination has created universal drug dependence that is less effective than the natural maternal antibody protection. Secondly, the many adverse effects of vaccines lead to numerous health consequences. Thirdly, vaccines have pushed childhood diseases into infancy and adulthood.

Vaccination Interferes With Immune Development

The maturation of the immune system is accomplished by learning how to mount an acute, vigorous response to an infection. Childhood diseases such as measles, mumps, chicken pox, influenza and other infectious diseases are considered 'challenge illnesses' that prime and develop a child's immune response. Recovering from a childhood illness is "the formative experiences by which good health is achieved and maintained." ⁴ Vaccination removes this significant evolutionary step from a child's immune development. The long-term effect of this is unknown.

Measles is known to have a protective effect against many diseases including cancer, heart disease, malaria, allergic diseases, and juvenile rheumatoid arthritis. Developmental leaps have been observed in children following measles. Chicken pox exposure reduces the incidence of shingles in adults. Mumps helps prevent ovarian cancer. ⁴

Dr. Richard Moskowitz, a physician with more than fifty years of clinical experience, has concluded that the artificial suppression of disease by vaccination is detrimental to our overall health and well being.

Vaccination Causes New Strains to Emerge

Vaccines cause microbes, bacteria and viruses to mutate. This can result in the growth of disease strains that are more severe and resistant to current medical treatments. We witnessed this phenomenon with the excessive use of antibiotics.

Haemophilus influenza B is an example of a disease that was effectively suppressed by vaccination. Other serogroups, however, rose to displace the strain suppressed by the vaccine. The same phenomenon occurs with the HPV vaccine. Thus the need to continually add more strains to the vaccine.

In response to mass pertussis vaccination campaigns in the 1950s, the B. pertussis microbe evolved to evade both whole cell and acellular pertussis vaccines, creating new strains producing more toxin to suppress immune function and causing more serious disease. This is the primary reason for the outbreak of pertussis today.

The rapid altering of disease strains via vaccination may actually put humanity more at risk of a pandemic infection to which our immune systems are not able to respond.

Anti-bodies Do Not Equal Immunity

The CDC claims that, "Immunity to a disease is achieved through the presence of antibodies to that disease." The CDC deems a vaccine to have efficacy solely on the basis that it increases antibody levels in the blood. Research, however, demonstrates that an individual can have immunity with low or no antibodies, while others can become infected even when antibody levels are high.

Our immune response is significantly more complicated than the level of antibodies in our blood.

Vaccines Compromise Health

Good health is dependent upon a healthy body and a strong immune system. The injection of multiple antigens, adjuvants, toxic and foreign matter can overwhelm the immune system and impede its ability to fight infection. Immunologists have expressed concern that the growing number of vaccines given early in life may impair immune function for life.

Studies show a dose dependent relationship between the number of influenza vaccines received and susceptibility to a pandemic virus. ⁵ A 2017 study revealed that women who had received the H1N1 influenza shot and then received a normal influenza vaccine were 7X more likely to have a spontaneous abortion. ⁶

Vaccination is essentially an artifice, designed to trick the immune mechanism into providing a semblance or counterfeit of immunity that is partial, defective, and temporary at best, and that carries substantial additional risks of its own.

Vaccine Impact is Dishonest

The pharmaceutical industry and mainstream media routinely refer to vaccines as 'a miracle of modern medicine', a distinctly unscientific term. Vaccines are consistently described with no conditions or qualifiers and an absence of supporting evidence.

Vaccines are regularly credited with the reduction in the mortality of infectious diseases, the elimination of small pox and polio, and having saved millions of lives. The historical and scientific evidence does not support such claims.

While some vaccines have suppressed the incidence of some infectious diseases, the significant reduction in mortality and the improved health in the last century occurred <u>before</u> the introduction of vaccines. Diseases like scarlet fever and the plague were eliminated without the benefit of any vaccine. Giving vaccines credit for the elimination of infectious disease and the decline in mortality is a myth, albeit a popular one.

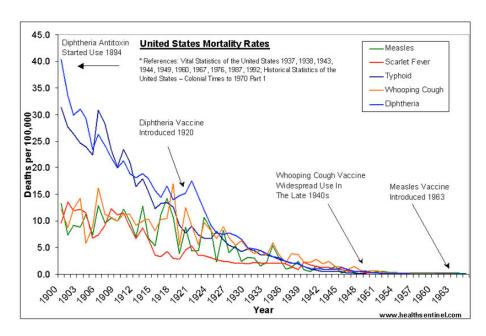
Contrary to popular belief, vaccines did not eliminate either small pox or polio. ^{1 2} There is substantial evidence these early vaccines actually contributed to an increase in both diseases and caused more injury than the disease itself. ³

During the 'polio epidemic' in the 1950s, every case of paralysis was deemed to be caused by the polio virus. We now know that most of the paralysis was in fact not caused by the polio virus. Scientists now recognize that other viruses like Coxsackie, echo and enteroviruses caused paralysis, as did exposure to neurotoxins such as lead, arsenic and DDT.

Poliovirus infection, even during the peak epidemic, was a low-incidence disease that was falsely represented by the pharmaceutical industry as a rampant and violent crippler. Paralytic conditions still exists today. The World Health Organization has simply relabeled the paralysis as *Acute Flaccid Paralysis*. In 2012, India reported 60,292 cases of acute flaccid paralysis. Indian doctors have observed that 'non polio acute flaccid paralysis' increases with the number of doses of oral polio vaccine distributed in the country. ⁴

Prior to the discontinuation of the oral polio vaccine in the US, the oral polio vaccine caused all cases of polio.

When one gets the history wrong, this leads to getting our public health priorities wrong.

Vaccine Safety Claims Are Dishonest

The medical industry consistently makes the unqualified claim that vaccines are "safe and effective". How can vaccines be "safe and effective" when more than \$3.7 billion has been paid in compensation for vaccine injury in the United States?

In addition, the vaccine industry has been forced to withdraw more than 32 vaccines from the US market because of the ineffectiveness or harm these vaccines caused. ⁵ The list of withdrawn vaccines includes: small pox, swine flu, DPT, MMR, rotavirus, and oral polio vaccines, among others.

The polio vaccine given to 100 million Americans during 1955-1963 was contaminated with a monkey virus known as SV 40. SV40 causes cancer in humans. It is now widely recognized that the polio vaccine contributed to the significant increase in cancers we experience today. ⁶

The Vaccine Industry Distorts the Risk of Disease

The vaccine industry greatly exaggerates the risk of contracting diseases targeted by vaccines. The true potential of a vaccine ought to be assessed based on the number of people who developed **a** serious complication following infection, rather than the infection itself. What is rarely discussed in vaccine promotion literature is the rate of serious complications in the pre-vaccine era. The rate of serious complications in the pre-vaccine era were as follows: ⁷

Measles – In the years preceding the introduction of the measles vaccine in 1963 the death rate from measles in the US population was 1 in 500,000 people.

Mumps – Prior to the mumps vaccine in 1967, about 1 in 4 million people in the US population died from mumps.

Chicken pox – In the population as a whole, prior to the introduction of the chicken pox vaccine, 1 in 2.3 million Americans died of complications from chicken pox each year.

Rubella – The fatality rate prior to the widespread use of the rubella vaccine in 1969 was 1 person in 9 million in the US population. The rate of birth defects in pregnant women was about 1 in 20,000 births.

Hib – Before the Hib vaccine was introduced in 1985 about 1 in 2 million people in the U.S. population died annually from meningitis. The risk of permanent harm from meningitis was about 1 in 600,000 in the US population.

Rotavirus – Prior to the vaccine being introduced in 2006 about 1 in 10 million in the U.S. died from rotavirus.

Polio – Before widespread use of the vaccine in 1955 the permanent paralysis rate or death from polio in the U.S. population was 1 in 100,000 people.

Unfortunately, our trust in institutions, organizations and authority is being eroded because honesty and integrity is being sacrificed in the interest of profit and power.

At one time we could rely on the declaration that consensus was reached. Consensus is a powerful tool that is regularly used to reassure us that a particular perspective or course of action has been well researched, discussed, debated, and a conclusion reached based on solid evidence. Efforts are made to reassure us by the power of consensus whether the issue is the safety of genetically modified organisms, the validity of climate change, the safety and effectiveness of vaccinations, the quality and integrity of industrial safeguards, or even the need for war.

Unfortunately, according to Jon Rappoport, author of *The Matrix*, the process of consensus building has become much less collaborative and evidence-based and is more often "manufactured."

The manufacture of consensus looks like the following:

- 1. An 'authority', often unnamed, declares an idea or a perspective as fact.
- 2. Respected individuals, groups, governmental organizations and the media repeat the authoritative message over and over as if it is fact.
- 3. The position is taken that because consensus has been reached further discussion and debate is no longer needed or tolerated.
- 4. Critics and dissenters of the consensus position are attacked. Shock and dismay is expressed that there are "still people who refuse to accept the obvious."
- 5. Warnings are issued and dire consequences predicted if everyone does not accept the consensus idea or perspective.
- 6. Carefully constructed 'scientific' studies are produced to support the consensus position.
- 7. A declaration is made that the consensus idea or position represents 'the greatest good for the greatest number'.
- 8. Legalized coercion through the introduction of new laws and regulations is introduced to prevent anyone from holding or expressing a dissonant opinion or position.
- 9. Any dissenter is relegated to the margins and dismissed with labels that deny them a voice or any credibility regardless of their experience or stature.
- 10. Eventually no one can recall a time when the original idea was seriously disputed.

Science once offered us confidence that a statement, fact or conclusion was true based upon a rigorous and verifiable process using the scientific method. This is an accepted method to produce verifiable data that will serve in the best interests of truth. Unfortunately the scientific method, a process of hypothesis, data collection, analysis and confirmation or refusal of the hypothesis has been corrupted.

Where once we could trust the scientific method, today science is being co-opted for economic and political gain and is no longer a valid seal of approval.

Science, like other aspects of our society, has been corrupted by power and politics. It is no longer in service to the truth.

Rather, it is in service to those in positions of power and who have enough money to determine the outcome of 'science'. Consider these two quotes from editors of prestigious science/medical journals:

It is simply no longer possible to believe much of the clinical research that is published or to rely on the judgment of trusted physicians or authoritative medical guidelines.

I take no pleasure in this conclusion, which I reached slowly and reluctantly over my two decades as an editor of the New England Journal of Medicine.

Rappoport explains that these efforts to manufacture consensus are effective because people have a minimal tolerance for conflicting views on subjects of key importance. He believes humans are wired for consensus.

While consensus is certainly desirable, the question is whether the consensus is based on solid, supported evidence, and whether the good that is being promoted is indeed for the greater good or whether the consensus has been manufactured for the benefit of a small group of individuals or organizations.

We need to be more discerning of whether the consensus is worthy of our respect.

Who is the individual or group declaring consensus? Is there integrity in their decision-making process? Is there a willingness to let the science speak? Is there investment in a particular outcome? Are there economic, political or strategic interests that can compromise the integrity of the decision? Is there independent access to the supporting data? Are we giving away our responsibility for decision-making to those who have not earned our trust? Are we unduly influenced by the authority of government, the medical community and the media? Are we willing to think for ourselves?

We would be wise to be cautious in accepting consensus positions when other motives are involved that can corrupt a true consensus process.

When an organization uses marketing propaganda instead of science, there is a reason.



Can Vaccine Oversight Be Trusted?

Doctors Not Taught to Recognize Vaccine Injury

Doctors receive no formal training on how to diagnose or treat vaccine injury. Absent from current medical school curriculum is complete and up-to-date information about vaccine ingredients, diagnosis and treatment of vaccine injury, adverse events reporting, and individual genetic susceptibilities to vaccine injury.

The harm this causes is significant. A doctor's failure to recognize and report vaccine injury puts other children at risk for the same fate. Their failure to acknowledge vaccine injury also discourages the development of safer vaccines or alternative methods of immune support and disease prevention.

The reporting of vaccine injury is essentially voluntary as there are no consequences for failing to report vaccine injury. A Harvard Pilgrim Health Care study found that less than 1% of vaccine adverse reactions were reported. ¹

A doctor's inability to recognize vaccine injury prevents families from getting the help they need. A doctor's inability to acknowledge vaccine injury undermines informed consent. Informed consent is only as informed as your doctor is informed.

The CDC Admits To Limited Knowledge of Risks

According to the CDC's website, ² the Institute of Medicine (IOM) concluded that "there are limitations in our knowledge of the risks associated with vaccines". The IOM identified the following problems:

1. Limited understanding of biological processes that underlie adverse events.

- 2. Incomplete and inconsistent information from individual reports.
- 3. Poorly constructed research studies.
- 4. Inadequate systems to track vaccine side effects.
- 5. Few experimental studies were published in the medical literature.

CDC policies and decisions directly affect vaccine policies in nations worldwide. It's important to question why various governments are mandating vaccines when so little is known about the long-term impact of universal mass vaccination.

Vaccine Producers Pay Billions in Penalties

Every US manufacturer and supplier of pediatric vaccines has pled guilty to fraud in the last four years.

Vaccine producers Merck and GlaxoSmithKline have paid billions in criminal penalties and settlements for research fraud, faking drug safety studies, failing to report safety problems, bribery, kickbacks and false advertising. ³⁴

There are two active whistleblower cases in the US Federal Court against Merck alleging scientific fraud with regard to their claims of the safety and effectiveness of the MMR vaccine.

The CDC Has Conflicted Interests

The *Center for Disease Control* has conflicted interests. The CDC is responsible for monitoring the safety of vaccines, and at the same time they have a mandate to increase vaccine uptake. The CDC is both a regulatory agency and a major corporation in the vaccine industry.

Most people are unaware the CDC is effectively a for-profit corporation. The CDC holds patents on over 50 vaccines and sells more than \$4.5 billion worth of vaccine products each year. Acknowledging concerns about the safety of vaccines would negatively affect their revenues.

Federal conflict of interest rules do not apply to the CDC. Those responsible for licensing vaccines routinely benefit from the sale of vaccines. We shouldn't have to wonder if those in the CDC are acting in the public's best interest or their own.

Vaccine Producers Not Accountable to the Public

The vaccine industry is projected to be a \$59 billion industry by 2020. ⁵ Its goal, like all businesses, is to have the highest financial return possible. They do this by eliminating competition, using advertising and propaganda to promote their products, and they employ lobbyists to influence governments. According to Robert Kennedy Jr., the pharmaceutical industry has four times as many lobbyists in Washington as the military-industrial complex. The vaccine industry is not accountable to the public. They are only accountable to their shareholders. Profit is what matters.

Inadequate Post Marketing Monitoring

The post-marketing monitoring of vaccine products is grossly inadequate. One problem is that the monitoring of vaccine safety is passive rather than active. A passive system only recognizes a tiny percentage of vaccine adverse events. The real number of children and adults experiencing vaccine injury is unknown.

A second concern is that medical professionals receive no formal training on how to recognize vaccine adverse events or report vaccine injury.

Public information related to vaccine safety is inadequate to enable parents and governments to make informed vaccine decisions.

Thirdly, vaccine producers do not know the long-term impact of the current vaccine schedule on our neurological and immune systems. ⁶ This is because vaccine producers are not required to conduct long-term safety studies. Most safety studies last a few weeks. Some are as short as a few days. ⁷

Fourthly, vaccine producers are not required to conduct vaccinated vs. unvaccinated studies to prove that vaccines are safe and effective. Vaccine producers are able to market their products with less safety testing and oversight than is required with any other pharmaceutical drug.

Finally, there is substantial evidence that the CDC has repeatedly committed scientific fraud in its vaccine safety studies. This is particularly true with studies examining the role of vaccines in the autism epidemic. ⁸ Without proper monitoring and oversight the whole premise of vaccination safety, effectiveness and necessity is speculation rather than evidence based.

Abuse of Mature Minor Doctrine

The 'mature minor doctrine' is a term for the statutory, regulatory or common law policy, which accepts that a minor may possess the maturity to choose a particular health care treatment without the knowledge or agreement of his or her parents. This policy, incorporated into various Health Acts in Canada and the United States, was originally intended to allow adolescents to freely access birth control and abortions.

Schools and public health agencies now use this doctrine to coerce children as young as eleven to consent to vaccination without parental knowledge or consent. A document from the *Canadian Teachers Federation* lauds the cost effectiveness of the school vaccination platform and the power of leveraging the authority of schools and threat of suspension to pressure students to 'consent' to vaccination.

Children are told that they can sign their own consent form without consulting his/her parents. Rarely are these children told that they have the legal right to vaccine exemptions; that vaccination, like any medical treatment is voluntary; nor are they provided with adequate information on vaccine risks. This means that real informed consent is being denied.

Vaccination Clinics Don't Belong in Schools

Vaccination clinics held in school cafeterias are an exercise in herding students through a process as quickly as possible. Students are not given privacy to voice medical concerns. The practitioners providing the injection often have no knowledge of the student's medical or family history. And the simple act of rolling up one's sleeve is deemed evidence of consent. It is clear that protocols to insure that the consent of minors is informed and voluntary are inadequate.



Can Vaccine Journalism Be Trusted?

Dr. Peter Doshi, Associate Editor for the British Medical Journal (BMJ) made the following statements about good journalism as pertains to vaccinations:

"Good journalism on this topic will require abandoning current practices of avoiding interviewing, understanding, and presenting critical voices out of fear that expressing any criticism amounts to presenting a "false balance" that will result in health scares.

If patients have concerns, doubts, or suspicions — for example, about the safety of vaccines, this does not mean they are anti-vaccine.

Approaches that label anybody and everybody who raises questions about the right headedness of current vaccine policies as "anti-vaccine" fail on several accounts.

Firstly, they fail to accurately characterize the nature of the concern. Many parents of children with developmental disorders who question the role of vaccines had their children vaccinated . . . and people who have their children vaccinated seem unlikely candidates for the title.

Secondly, they lump all vaccines together as if the decision about risks and benefits is the same irrespective of disease – polio, pertussis, smallpox, mumps, diphtheria, hepatitis B, influenza, varicella, HPV, Japanese encephalitis — or vaccine type — live attenuated, inactivated whole cell, split virus, high dose, low dose, adjuvanted, monovalent, polyvalent, etc.

This seems about as intelligent as categorizing people into 'pro-drug' and 'anti-drug' camps depending on whether they have ever voiced concern over the potential side effects of any drug.

Thirdly, labeling people concerned about the safety of vaccines as 'anti-vaccine' risks entrenching positions. The label (or its derogatory derivative 'anti-vaxxer') is a form of attack. It stigmatizes the mere act of even asking an open question about what is known and unknown about the safety of vaccines.

Fourthly, the label too quickly assumes that there are "two sides" to every question, and that the "two sides" are polar opposites. This "you're either with us or against us" thinking is unfit for medicine.

Contrary to the suggestion — generally implicit — that vaccines are risk free (and therefore why would anyone ever resist official recommendations), the reality is that officially sanctioned written medical information on vaccines is — just like drugs — filled with information about common, uncommon, and unconfirmed but possible harms.

Medical journalists have an obligation to the truth.

Its time to listen—seriously and respectfully—to patients' concerns, not demonize them."

The vaccine industry, including the government agencies mandated with the responsibility for vaccine oversight is gambling.

They are gambling that the best way to preserve public confidence in the vaccine program is to deny and disavow any claims that vaccines have a role in the serious adverse events that are routinely witnessed following vaccination.

Rather than investigate every act of injury or suspected harm as occurs in other industries, most notably the airline industry and the food industry, the vaccine industry has adopted the mantra of "safe and effective" and "vaccines do not cause autism". When the number of recommended vaccines and the number of reported adverse events was low, this strategy held a high likelihood of success. The number of injuries was not significant enough to capture the attention of the mass consciousness.

As the number of recommended vaccines has grown from a handful to 69 doses of 16 vaccines by the age of eighteen the number of children injured or killed by vaccines has reached epidemic proportions. 1 in 6 has a chronic neurological or immunological condition. The house of cards that forms the basis of the vaccine paradigm is faltering.

It is a well-known fact in toxicology that contaminants exert a mutual synergic effect, and as the number of contaminants increases, the effects grow less and less predictable. With each new vaccine added to the recommended schedule the complexity of drug interactions and the mounting toxic load increases the certainty of a collapse.

A wise and safety conscious industry would evaluate the risk of collapse and carefully manage the number of vaccines injected into children. They would know that a system based on trust can dissolve overnight as occurred with the dot.com bubble and the financial and housing meltdown of 2008.

But the vaccine industry is not wise. It is not safety conscious.

It sees only unlimited potential for growth and profit. It has been lulled into complacency and the illusion of invulnerability by the 1986 Act of Congress, which relieved the vaccine industry of all legal liability for the safety of their products.

This lack of legal liability and accountability, the assurance of a captured and expanding market due to government imposed mandates, and the lack of any real investigative journalism by the 'not so free press' has produced a climate of exponential growth that is too attractive and financially rewarding to resist.

Instead of being committed to producing safe and effective products, the vaccine industry is in a race to produce as many vaccines as possible while lobbying corruptible governments to increase mandates for school attendance, daycare, housing and employment.

How many of the 270 vaccines currently under development will be mandated is anyone's guess given the present consciousness.

What the vaccine industry hasn't taken into consideration is that parents are waking up to the harm that is being done to their children. Parents whose children have been permanently harmed or killed by vaccines are refusing to be coerced into subjecting their children to more vaccines. They are 'mad as hell and are not going to take it anymore'.

These parents are refusing to be intimidated into silence by a captured and compliant corporate media. The chants of "correlation does not equal causation" mean little when your once healthy child is experiencing uncontrolled seizures or requires 24-hour care for the rest of his or her life.

The outcome of this uncontrolled experiment is not in doubt. The blind faith and unearned trust in the vaccine program and its high priests will come to a sudden and dramatic end. The vaccine industry will collapse under the weight of its own fraud, immorality and callous disregard.

The only question is how many more children, teenagers and adults will be injured or killed by vaccines before the awareness is substantive enough to cause this teetering structure to fall.

The collapse will be swift.

Like the housing market in a faltering economy and stocks in a financial meltdown, soon the vaccine industry will not be able to give their products away. Vaccines will be avoided like the plague they were intended to protect us from. And whatever good was hoped for by the architects of the artificial immunization program will be lost for generations as trust, once abused will be difficult, if not impossible to reclaim.

The vaccine industry could have avoided this collapse but they were too greedy and too callous in their disregard for those injured by their products.

I suggest the collapse has already begun. The once revered medical industry is losing its appeal, and the growing awareness of massive vaccine injury can no longer be contained.

Thankfully, the end is near.

A mass vaccination program carries a built-in temptation to oversimplify the problem; to exaggerate the benefits; to minimize or completely ignore the hazards; to discourage or silence scholarly, thoughtful and cautious opposition; to create an urgency where none exists; to whip up an enthusiasm among citizens that can carry with it the seeds of impatience, if not intolerance; to extend the concept of the police power of the state in quarantine far beyond its proper limitation; to assume simplicity when there is actually great complexity; to continue to support a vaccine long after it has been discredited; (and) to ridicule honest and informed consent.

There are a number of questions we ought to be asking and demanding answers to regarding the medical practice of artificial immune stimulation:

- 6. Do we have a responsibility to those children, their families and potential vaccine victims to conduct independent vaccine safety studies?
- 7. How many children are we willing to sacrifice in pursuit of the theory of 'herd immunity' or 'the common good'. Who decides which child's life is worth sacrificing?
- 8. Why has only one independent long-term clinical study been conducted that compares the health of vaccinated vs. never vaccinated individuals? Why have the results of this study not been made publicly available?
- 9. Why is the low incidence of autism in non-vaccinated children not a serious matter of investigation by the CDC, and why is this important fact rarely reported by the mainstream media?
- 10. Why is discussion about this controversial medical practice actively discouraged by governments, the media, and vaccine manufacturers?

There are two kinds of parents who come to Vaccine Choice Canada.

One group of parents recognizes they have a right and a responsibility to make an informed decision about the medical practice of vaccinations. These parents, prior to the birth of a child or even pre-conception, thoughtfully engage in educating themselves about the risks and benefits of vaccination.

Admittedly the number of parents who proactively engage in the vaccine decision is small. Given the overwhelming intensity and uniformity of the messaging by the medical industry and the magnification of these messages in the mainstream media, it is unusual for a young parent to question the safety, effectiveness and necessity of vaccines and thus engage in any real self-education.

By far the majority of parents who contact Vaccine Choice Canada are parents who trusted the direction of their doctor. They believed that the 12 vaccines given in 26 doses in the first 12 months of life (Ontario recommendations) were all safe, effective and necessary, only to witness significant injury or regression following the vaccination of their child.

A once content baby is suddenly inconsolable. A walking infant is now unable to stand. A talking child is now silent. An alert and attentive baby becomes unengaged. Instead of a happy, content and healthy child these parents suddenly have a child with agitation, poor attention, diarrhea, rashes, allergies, lethargy, and seizures.

Some children go on to develop autoimmune diseases, immune system and neurological injuries, and some tragically pass away as mine did.

Something Is Wrong

Even though their Doctor tells these parents that any relationship between a vaccine and injury, disability or death is simply a "coincidence", these mothers and fathers know better. They know something is terribly wrong with their child.

The child they knew prior to the vaccinations is gone.

This is when many parents reach out to Vaccine Choice Canada. This is when the serious investigation of a vaccine's ingredients, adverse effects, and the pursuit of information on vaccine safety and effectiveness begin in earnest.

This awakening of parental concern *after* a vaccine injury is, unfortunately, all too common. Most of us at Vaccine Choice Canada are parents who willingly and naively subjected our children to the dictates of the medical industry, only to discover that vaccines were not safe and effective for our child.

Their first task is to find what treatments might heal their injured child. Who is knowledgeable about vaccine injury? How can these heavy metals be removed? How do I heal a leaky gut? How do I restore health? How do I support a compromised immune system? How do I undo the neurological damage that has been done?

Sometimes answers are found and their child makes a full recovery. Often times the damage is irreversible.

After having attended to their ailing child and having done all they can to recover as much health and capacity as possible, many of these parents begin a new journey. They take on a new focus and passion. They become advocates for informed consent.

They want other parents to know the risks and dangers of the current artificial immunization program. They want other parents to avoid the mistake they made. They want the medical industry to be held accountable for their actions and their unsafe products. They want the mainstream media to tell the truth about vaccines.

Natural Means of Disease Prevention

Vaccine marketing has distracted attention and effort away from natural means of disease prevention and health promotion including clean air and water, good hygiene and nutrition, reducing exposure to toxins, and quarantine when needed.

Below is a summary of some of the natural and effective immune supports that have been ignored or minimized in the single focused promotion of vaccine products.

Clean Water

Researchers Cutler and Miller identified that clean water is critical to disease prevention and to the decline in infant mortality. In their 2004 paper ² they concluded:

Our results also suggest that clean water was responsible for 3/4 (74%) of the decline in infant mortality and nearly 2/3 (62%) of the decline in child mortality.

The magnitude of these effects is striking. Clean water also appears to have led to the near eradication of typhoid fever [and other] scourges such as pneumonia, tuberculosis, meningitis, diphtheria/croup.

Clean water technologies are likely the most important public health intervention of the 20th Century.

If governments were really concerned about health, they would be using their resources to ensure that all citizens in the world have access to clean water.

Building Natural Immunity With Food

"The decision not to vaccinate does not mean that parents can be careless about protecting their children from disease. While some of the illnesses we vaccinate for are extremely rare (tetanus, diphtheria), unlikely to cause harm to children (chicken pox, mumps, rubella) or not a threat to children (hepatitis B), others like measles or polio can have serious consequences in poorly nourished youngsters.

It's up to parents to provide the kind of diet that will give their child robust natural immunity— that's the same kind of diet that will give a child good health overall. It's also a diet that can help your child recover from vaccination injuries.

Here's a list of recommendations to keep your children healthy and strong:

Foods Rich In Vitamin A

Vitamin A is our number one protection against disease. The immune system cannot function without vitamin A. Two important points about vitamin A:

- First, we cannot get adequate vitamin A by converting the carotenes in fruits and vegetables into the true vitamin A.
- Secondly, vitamin A requires vitamins D and K2 as cofactors. Foods that provide us with vitamin A, usually also contain vitamins D and K2—foods like butter from grass-fed cows, egg yolks from pastured chickens, aged natural cheese, shellfish and organ meats like liver.

In addition to these foods, cod liver oil can provide vitamins A and D on a daily basis.

Before the advent of vaccinations, the medical profession knew that the vitamin A in cod liver oil would protect children against all sorts of infections.

Moms are recommended to take cod liver oil while pregnant and nursing, and to begin giving it to their children around two or three months. Use only cod liver oil containing natural vitamins. (See westonaprice.org/cod-liver-oil/ for more information and product recommendations)

Raw Milk

Raw milk is a complete, highly digestible food for growing children. It is also a powerful immune builder. A key component of our immune system is antibodies, such as immunoglobins, which are found in raw milk.

Vaccines are supposed to work by stimulating the production of antibodies, but babies cannot make antibodies, including vaccine-induced antibodies, until they are at least one year old. Yet babies today get over a dozen vaccines before the age of one.

Babies get antibodies from their mother's milk, or from the milk of another species. In fact, raw milk—whether human, cow, goat, sheep, camel, reindeer or water buffalo—contains all the components of blood except for red blood cells.

Raw milk creates the immune system in the infant, and nourishes that immune system throughout the period of growth. All of these valuable immune components, however, are destroyed by the heat of pasteurization.

Studies from Europe indicate that children who drink raw milk have fewer respiratory infections and less asthma, allergies and skin rashes compared to children who do not consume raw milk. (For more information, and to find raw milk, visit realmilk.com.)

Fermented Foods

Fermented foods like raw sauerkraut, homemade kefir and aged raw cheese contain beneficial protective bacteria. Eaten on a daily basis, the bacteria in these foods colonize the intestinal tract where they provide powerful protection against pathogens.

During the past twenty years, scientists have learned that gut bacteria are critical to health. In fact, about 80 percent of our immune system comes from beneficial gut flora. In addition, the biofilm of good bacteria in the gut provides a barrier to heavy metals like aluminum and mercury.

Avoid Processed Foods

In this age of industrial food production it's difficult to avoid processed foods, but parents will confer the great blessing of good health on their children by keeping them away from processed food. Especially avoid refined sweeteners like sugar, high fructose corn syrup and agave. Sugar uses up nutrients that the body needs to support the immune system.

Vegetable oils are also known to depress the immune system, while natural saturated animal fats support the immune system. Cook in animal fats like butter and lard, and give your children butter instead of margarine and spreads. Make your own salad dressing using olive oil rather than purchase ready-made dressings, which are made with the cheapest oils and loaded with additives.

In short, the recipe for protecting your children from disease and ensuring they will grow up healthy and strong is an oldfashioned, home-prepared diet rich in butter, eggs, cheese and nutrient-dense animal foods like liver and red meat. Fruits and vegetables can serve as vehicles for butter and cream!

The addition of raw milk, fermented foods, bone broths and, above all, cod liver oil to your child's diet will compensate for the occasional junk food that cannot be avoided. This is the Wise Traditions diet—vastly superior than vaccinations for protecting your children from disease throughout their growing years."

How To Minimize Vaccine Injury

If you must vaccinate, you can reduce the risk of vaccine injury in your children with the following guidelines:

- 1. Consider delaying as long as possible. Some medical doctors recommend waiting at least two years until the child's immune system is more developed.
- 2. Breastfeed your infant. Breastfeeding provides your infant with a sophisticated living immune system, which responds to pathogens that your child may be exposed to.
- 3. Give large doses of Vitamin C to your child before any vaccination. This will help to reduce the negative side effects.
- 4. Never vaccinate your child when he or she is sick.
- 5. Refuse any vaccine that uses mercury as a preservative.
- 6. Request vaccines with the lowest aluminium content.
- 7. Refuse to allow your child to receive multiple vaccines at once. Request single dose vaccines.
- 8. Space out the shots to allow you to monitor your child's response to each vaccine.
- 9. Don't continue to vaccinate if your child has a reaction to a shot. Educate yourself on what vaccine adverse events may look like.

- 10. Request and read the product information insert for each vaccine. Don't rely on your doctor to inform you of the risks and contraindications.
- 11. Find a doctor who respects your questions and your concerns.
- 12. Consult with a Naturopath. Investigate homeopathic remedies and other immune supports. Homeopathic remedies can reduce the injury caused by vaccination.
- 13. Trust your intuition. If it doesn't feel right, don't do it. No one knows your child better than you do.
- 14. Do not be pressured into vaccinating your child simply because it's the "recommended schedule".
- 15. The fewer vaccines, the better. Research shows the risk of injury increases with the number of vaccines given and the earlier they are given.
- 16. Know your rights. Become a member of a vaccine choice advocacy organization. Most jurisdictions have exemptions for medical, religious and personal belief.
